The Arizona Fine Art EXPO is located at the southwest corner of Jomax and Scottsdale (at the traffic light). The EXPO is nestled in the most affluent and upscale area of North Scottsdale only 5 miles south of Carefree and 5 miles north of the Loop 101.

The application fee includes a variety of opportunities for ten weeks such as; rented working space, gallery presentation for hanging artwork, art sales, paid staff assistance, artist's personal site on our website (www.arizonafineartexpo.com), patron interaction, camaraderie with fellow artists and own list of patron contacts. Unless other arrangements are agreed upon in advance, artists are expected to be present a minimum of five to six days a week, including Fridays, Saturdays and Sundays or have a representative in their absence. A limited number of outdoor working cabanas are available for welding, clay & raku firing, patina finishing, glass fusing, etc. on a first come, first serve basis.
